

ESG是什么/ About ESG

ESG= Environment 环境+ Social 社会 + Governance 治理

- ▶ E (环境): 指公司在环境方面的积极作为，包括符合现有的政策法规、关注气候变化对未来的影响等。

Focus on environment protection, climate change, risk mitigation, etc

- ▶ S (社会): 指平等对待利益相关者、维护公司发展的社会生态系统，如健康安全，性别平等等。

To fairly treat stakeholders and create sustainable community; human rights, labor practice, etc

- ▶ G(治理): 是公司治理环境、治理结构、治理机制和治理行为综合形成和作用的结果。

Focus on corporate governance structure, management approach, business ethics, etc.



为什么要谈ESG/ Why talk about ESG

- 包括政府、监管部门、客户、消费者等在内的利益相关者在向企业施压，迫使企业更积极地应对气候变化等挑战。

Stake holders including government, regulatory, client, customers are pushing companies to deal with challenges such as climate change.

- 投资者越来越关注企业在社会和环境领域的表现，有证据表明，企业在这些方面的表现将影响其投资回报。

Increasing investors' focus on companies' social and environmental performance. There are evidences showing that companies' ESG performance will impact the ROI.


